  - c. Copies of GST returns not submitted for 2018-19.
  - d. Certificate for continuous serving of food at least 1000 people as a single Unit for at least two years of last three financial years.
  - e. Non black listing certificate not produced in original and Xerox copy submitted which is not as per tender document format.
  - f. Proof for minimum 60 workers/staff on the EPF and ESIC rolls of the Service Provider's organization doing job in all of its Industrial/ Institutional Mess/Mess (Latest Three months TRRN for EPF and ECR for ESIC as proof for number of workers/staff on roll)
  - g. Valid labor license for 60 Nos.

h. Experience in serving Andhra Food at least for two years is mandatory. Menu copy pertaining to previous work orders duly certified by the competent authority is not submitted.

  - e. ESIC Registration proof.
  - f. Valid labor license for 60 Nos.
  - g. Undertaking certificate for not having any criminal cases not submitted.
  - h. Experience in serving Andhra Food at least for two years is mandatory. Menu copy pertaining to previous work orders duly certified by the competent authority is not submitted
  - i. List of present clientele not submitted.

### Hence it is not qualified.

16.M/S Saroja caterings & hostels did not submit original hard copies towards EMD, Processing fee and other documents and hence they are **disqualified** and not considered for further evaluation.
